

Terms and Conditions

1. Introduction

These Website Standard Terms and Conditions (these “Terms” or these “Website Standard Terms and Conditions”) contained herein on this webpage and application play store inclusive but not limited to android and iOS play store, shall govern your use of this website, mobile application on any platform, device on any platform or devices or in combination thereof, including all pages within this website (collectively referred to herein below as this “Website”).
